

An alarm strikes the number of the box, with a pause of five seconds between figures; it is twice repeated with ten second intervals. The first figure on the box also indicates the ward. One stroke of gong, fire out. The Gamewell Telegraph Fire Alarm system is used.

The figures and letters below after the streets, denote the number of *streets* and location the boxes are removed from the capitol square; or by subtracting one, will show the location by blocks.

from the corners of the Capitol square.

STREETS.

STREET NUMBERS.

Every space of twenty-two lineal feet frontage of lots or parts of lots on any street in the city of Madison should be numbered with a separate number and known thereby as follows: The numbers on all streets running northeast and southwest commence on Monona or Wisconsin avenues; and all streets running northwest and southeast commence at Washington avenue, in case said streets intersect said avenue, and such numbers run continuously from those avenues, one hundred numbers being assigned to the length of the block, so that the first number on the first block should be number one, the second block one hundred, and so on; the odd number should be on the southerly and easterly sides of the street, and the even numbers on the opposite side. All streets intersecting Washington avenue are known as North ——— Street in that part which lies northerly of said avenue; and South ——— Street in that part which lies southerly of said avenue; and all streets which intersect Wisconsin and Monona avenues are known as West ——— Street, in that part lying westerly of said avenues, and East —— Street, in that part lying east-erly of said avenues. Blocks upon streets running in directions which do not intersect said avenues should bear like numbers with the blocks upon streets which do intersect at like distances from those avenues, so far as practicable. It is the duty of each owner and occupant of any building or tenement fronting upon any street in the city of Madison to securely attach or apply to the front of such building or tenement, in a conspicuous position, and not higher than the first or ground story of said building, so that the same can be plainly seen from the street, the proper number of such building or tenement, as inscribed upon the map prepared by the city engineer, and on file in the office of the city clerk, in figures not less than two and one-half inches in height.

Atwood avenue, east of the Catfish, runs east from

Winnebago to the city limits.

Baldwin street is thirteenth e of the Capitol grounds and extends from E Johnson to Lake Monona.

Bassett street is fifth w of the Capitol grounds and

extends from Lake Monona, n to University ave.

Bedford street is sixth w of the Capitol grounds and extends from Lake Monona, n to W Dayton.

Blair street is sixth e of the Capitol grounds and ex-

tends from Lake Monona, n to Lake Mendota.

Blount street is seventh e of Capitol grounds and ex-

tends from Lake Monona, n to Lake Mendota.

Brearly street is tenth e of Capitol grounds and extends from Lake Monona, n to Lake Mendota.

Bridge street extends from Catfish n w to junction of

E Washington ave and Dickinson.

Brooks street is first w of Park, commences at University ave and extends s to W Dayton, and from Washington s to corporation line.

Broom street is fourth w of Capitol grounds, and extends from Lake Monona, n to junction of State and W

Gilman.

Bruen street is fourth w of Park, commences at University ave and extends s to Washington.

Butler street is third e of the Capitol grounds, and extends from Lake Monona, n to Lake Mendota.

Buell street is the second e of Catfish, and extends n from Winnebago to Railroad.

Canal street is fifth e of Capitol grounds, and ex-

tends from E Wilson, n to Lake Mendota.

Capitol grounds, central located, 2 blocks square, bounded n by Mifflin, e by Pinckney, s by Main, w by Carroll.

Carroll street is first w of Capitol grounds, and ex-

tends from Lake Monona to Lake Mendota.

Catfish, The, e Water runss from Lake Mendota to

Lake Monona.

Chandler street — Greenbush Addition — extends from the junction of W Washington ave and Murray, w to Garfield, Wingra Park.

Charter street is third w of Park; commences at University ave., and extends s to Washington ave.

Clymer street is second s of Capitol grounds; commences at S Henry, and extends w to C., M. & St. P. R'y tracks.

Dayton street is second n of the Capitol grounds and extends e from Wisconsin ave. to N Hamilton, and from N Blair e to Water; w from Wisconsin ave to State; w from N Henry to Warren.

Dickinson street is fourteenth e of Capitol grounds

and extends from E Johnson's to Lake Monona.

Division street, from Atwood aven e to Winnebago. Doty street is second s of Capitol grounds, and extends e from Monona ave to King and w from Monona ave to S Fairchild.

Drake street — Greenbush Addition — first s W Washington ave and extends from Lake Monona w to Gar-

field.

Emerald street — Greenbush Addition — second s W Washington ave and extends from Lake Monona w to Mills.

Erin street — Greenbush Addition — third s W Washington ave and extends from Lake Monona w to Mills.

Fairchild street is second w of the Capitol grounds

and extends from S Hamilton n to State.

Few street is twelfth e of Capitol grounds and extends from Lake Monona n to E Gorham.

First street is third e of Catfish, from Winnebago n to

E Washington ave.

Frances street is fourth e U. W. grounds, commences at C., M. & St. P. R'y grounds and extends n to Lake Mendota.

Gilman street is fifth n of Capitol grounds and extends from Wisconsin ave, e to N Butler, and from Wis-

consin ave, w to University ave.

Gorham street is fourth n of the Capitol grounds and extends from Wisconsin ave e to N Few; and from Wisconsin ave, w to University ave.

Hancock street is fourth e of Capitol grounds, and

extends from Lake Monona n to Lake Mendota.

Hamilton street commences at junction of W Main and S Carroll, and extends s to Lake Monona, and from junction of E Mifflin and N Pinckney n to E. Gorham.

Henry street is third w of Capitol grounds and extends from Lake Monona, n to Lake Mendota.

Hoyt's alley runs s from Dayton, bet. Murray and Park.

Ingersoll street is eleventh e of Capitol grounds, and extends from Lake Monona, n to Sherman ave.

Jane street is second w of University grounds, and

extends n from University ave to State.

Jenifer street is fifth s of E Washington ave, and ex-

tends from S Blount, e to Catfish.

Johnson street is third n of Capitol grounds and extends from Wisconsin ave, e to Water, and from Wisconsin ave, w to Warren.

Julia street is third w of University grounds and ex-

tends n from University ave to State.

King street commences at the junction of E Main

and S Pinckney, and extends e to S Butler.

Lake street is third e of U. W. grounds, and extends from C., M. & St. P. R'y grounds, n to Lake Mendota.

Lake street alley commences at University ave, bet.

Murray and Lake, and extends n to State.

Lake Mendota (or Fourth Lake), is the northern boundary of the city.

Lake Monona (or Third Lake), is the southern

boundary of the city.

Langdon street is sixth n of the Capitol grounds, and extends w from Wisconsin ave to Park.

Livingston street is eighth e of Capitol grounds, and

extends from Lake Monona, n to Lake Mendota.

Lorch street is fourth w of the University grounds, commencing at University ave, extending n to State.

Main street is first s of Capitol grounds, and extends from Monona ave, e to Water; from Monona ave, w to W Washington ave.

Mary street is first w of University grounds, and ex-

tends from University ave, n to State.

Mendota court, e side of Lake street, bet. Langdon' and Lake Mendota.

Merry street is first e of Catfish, and extends n from

Winnebago to Railroad.

Mifflin street is first n of Capitol grounds, and extends from Wisconsin ave, e to Water, and Wisconsin ave, w to C., M. & St. P. R'y.

Mills street is second w of Park, commences at Uni-

versity ave and extends s to city limits.

Milton street—Greenbush Additon—third n W Washington ave, extends from Murray, w to Mills.

Milwaukee street extends from Winnebago e to city limits.

Mound street — Greenbush Addition — second n W Washington ave, extends from Murray, w to Mills.

Monona ave, commences at Capitol grounds and extends s to Lake Monona.

Monona street is first w of C., M. & St. P. R'y track, and extends from W Washington ave s to Lake Mo-

Morrison street commences at S Baldwin, and extends e to Catfish, being ninth street s of E Washington ave.

Murray street is second e of University grounds, commences at State street and extends s to W Washington ave.

North street extends from Winnebago n e to city limits.

Park street commences at Lake Mendota, first e of University grounds, and extends s to W Dayton street, and from W Washington ave to city limits.

Patterson street is ninth e of Capitol grounds, and extends from Lake Monona, n to Lake Mendota.

Pinckney street is first e of Capitol grounds and extends from Lake Monona n to Lake Mendota.

Railroad street commences at S Blair bet E Main and E Wilson and extends e to Water street.

Rogers street is fifteenth e of Capitol grounds, and extends from Williamson street s to Lake Monona.

Rutledge street is seventh s E Washington ave commences at junction of S Ingersoll street, and extends e to Catfish river.

Seymour street runs w from Murray to Warren, on the n side of the C., M. & St. P. R'y track.

Sherman ave is fifth n E Washington ave., commences at the cor N. Brearly street, and extends northeasterly, crossing the Catfish river.

Spaight street is sixth s E Washington ave, commences at S Livingston, and runs east to Catfish river.

State street commences at the junction of N Carroll and W Mifflin streets, at the w cor. of Capitol grounds, and runs w to N Park, and from Mary street to the city limits.

Spring street commences at N Mills street bet. W Dayton and Washington streets, and runs w to Warren street.

University grounds is one mile w of Capitol grounds, bounded n by Lake Mendota, e by N Park, s by Uni-

versity ave, w by Mary.

University ave is a continuation of W Gorham, and runs from N Bassett w to city limits.

Warren street is the fifth w of N Park, commences

at University ave and runs s to Lake Wingra.

Washington ave, E, commences at the Capitol grounds, and runs e to Winnebago.

Washington ave, W, commences at the Capitol

grounds, and runs w to Garfield, Wingra Park.

Washington street commences at junction Murray street and the C. M. & St. P. R'y, and runs w to Warren.

Water street is sixteenth e of the Capitol grounds, commences at Lake Mendota and extends s to Lake

Monona.

Webster street is the second e of the Capitol grounds, and extends from King, to E Dayton.

Williamson street is the fourth s of E Washington

ave, commences at S Blair and runs e to Catfish.

Wilson street is the third s of the Capitol grounds, and extends from Monona ave, e to Water street, and from Monona ave, w to C. M. & St. P. R'y.
Winnebago is a continuation of Williamson street;

commences at Catfish and runs e to city limits.

Wisconsin ave commences at the Capitol grounds and runs n to Lake Mendota.

WINGRA PARK

Is a beautiful suburb adjoining the city plat at the extreme southwest, lying one-half mile south of the University of Wisconsin. It is bounded on the north by Garfield and Chandler streets, on the east by Warren street and Lake Wingra, on the south by Lake Wingra and Edgewood ave., and on the west by Monroe street.

STREETS.

The city system of street numbering is used with one exception, (every space of thirty-three lineal feet frontage should be numbered with a separate number), and to all intents and purposes this is an extension of the city plat.

Adams street is fourth e of Monroe, commencing at

Garfield, extends south to Edgewood ave.

Chandler street is part of northern boundry, commencing at W Washington ave, Greenbush Addition, and extends w to Garfield.

Cleveland street is third south of Chandler, commencing at Warren, extends w to Garfield.

Drake street is second south of Chandler, commencing at Lake Monona (Greenbush Addition), extending w to Garfield.

Edgewood ave is part of southern boundary, of Wingra Park, commencing at Lake Wingra, extends west to Monroe.

Garfield street is part of northern boundary of Wingra Park, commencing at Monroe, extends e to Chandler, thence s to Lake Wingra.

Grant street is first s of Garfield, commencing at Mon-

roe, extends e to Garfield.

Harrison street is second s of Garfield, commencing at Taylor, extends w to Monroe.

Jackson street is fourth e of Monroe, commencing at

Garfield, extends s to Edgewood ave.

Jefferson street is second e of Monroe, commencing at Garfield, extends s to Edgewood ave.

Lincoln street is fourth s of Garfield, commencing at

Lake Wingra, extends w to Monroe.

Madison street is first e of Monroe, commencing at

Garfield, extends s to Edgewood ave.

Monroe street is the western boundary of Wingra Park, commencing at Warren bet. W Dayton and Spring, extends s to Edgewood ave.

Polk street is fifth e of Monroe, commencing at Gar-

field, extends s to Lake Wingra.

Pierce street is fourth s of Chandler; commencing at Warren, extends w to Lake Wingra.

Taylor street is sixth e of Monroe; commencing at junc. Garfield and Cleveland, extends s to Lake Wingra.

Tyler street is fifth s of Chandler; commencing at

Warren, extends w to Lake Wingra.

Van Buren street is third s of Garfield; commencing

at Lake Wingra, extends w to Monroe.

Warren street is part of the eastern boundary of Wingra Park; commencing at University ave, extends s to Lake Wingra.

Washburn street commences at Chandler, and ex-

tends s to Lake Wingra, bet Warren and Garfield.

West Washington ave is first s of Chandler; commences at Capitol Park and extends w to Garfield.


