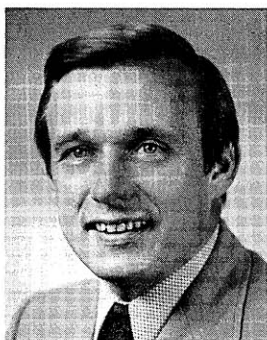

Elected to supreme court April 2, 1963 to fill vacancy resulting from the retirement of Chief Justice Timothy Brown.

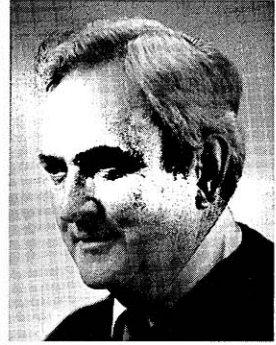

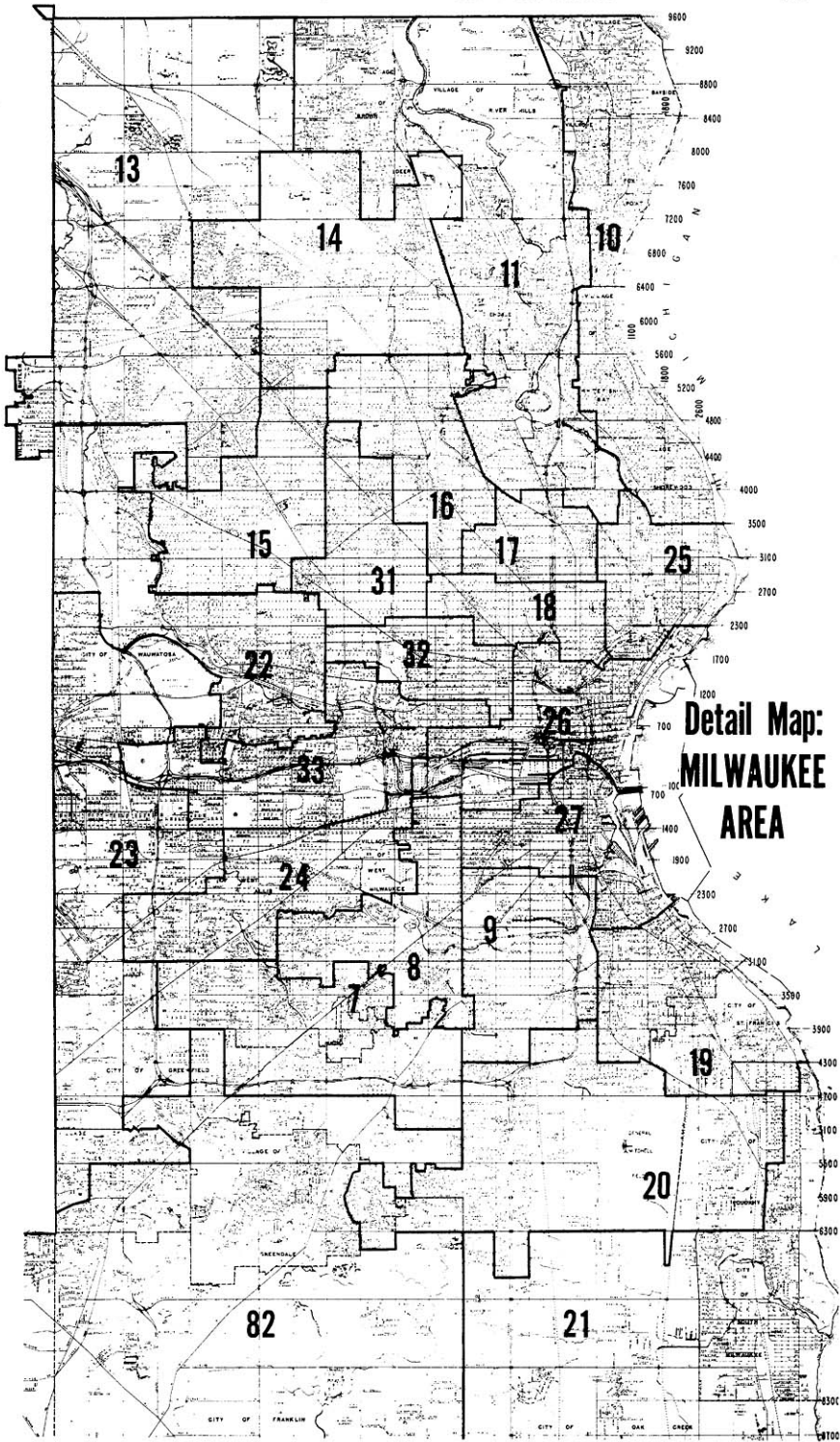
